# C. W. Cummins Dies Here at 82

Prominent St. Paul attorney Carl W. Cummins Sr., 82, of 684 S. Lexington ave., died Thursday in Miller hospital after a brief illness.

Mr. Cummins was long active in St. Paul civic, legal and community affairs. He was also active in scouting, sports and wildlife conservation work.

He was born in a sod hut near Groton, S. D., and had been a resident here 62 years.

He was a graduate of the St. Paul College of Law and for many years was a member of its faculty.

Mr. Cummins headed the law firm of Cummins, Cummins & Gislason.

During his long civic career he served two terms as president of the chamber of commerce and two terms as president of the community chest.

He also served as president of the St. Paul area Boy Scouts and participated in many scouting activities.

During World war II he was St. Paul civil defense director.
